Commission Secretary Mary Cremer read the following statement:

**Environmental Commission 2017 Budget:**

The Commission members spoke and collectively decided to keep the budget for 2017 the same. The Commission spoke in detail about how much it would cost for tree planting next year. There was movement of money allowance between categories, allowing more money for tree plantings in the upcoming year.

**Recycling Program Status**

Bob LaViano stated that he has not received any updates from Patti Nazzarro. He further suggested the co-mingling idea be researched by the Mayor and Council. Further suggested making contact with our recycling company and speak with them about how to make it easier for Saddle River residents to recycle.

Council Member Schulstad stated that Himself or Les Shenkler, Borough Administrator speak with the company after analyzing the Borough's contract.

The Commission members discussed having an enclosed garbage bin to keep garbage away from resident houses and safe from animals. It was further discussed that could cause zoning issues for some residents.

A motion was made to make 48 square foot garbage bins exempt from zoning ordinances by Jeff Liva. Seconded by Nik Aktas

**Shade Tree Replanting Program**

Bob LaViano stated that he feels that this program goes along with the Tree City application.

**Tree City Status**

Council Member Schulstad stated that he spoke with Commission Member Ron Yates who was absent at tonight's meeting. He further stated that Ron Yates informed him that the only thing missing from the application is the Mayor's signature. He further stated that he feels at this point the application, after being subject to final confirmation from the Environmental Commission is ready for Council action and the Environmental Commission should recommend the Mayor and Council to direct the Borough Administrator to ensure the tree city app is filed by the end of this year.

**Invasive Plant Control**

Bob LaViano stated that he feels this is a growing problem and has been ignored.

The Commission members discussed the different types of species that have become a problem including, bamboo, tree of heaven, barberry, Japanese knotweed, bittersweet, non-native sumac, poison ivy, Japanese barberry, garlic mustard, multiflora rose.

Council Member Schulstad stated that the Environmental Commission members should speak with Scott Levy to discuss their list of invasive species. It was decided that Jeff Liva would call Scott Levy, Borough Landscape Architect to review the list of invasive species.

A motion was made by Jeff Liva and seconded by Nik Aktas to recommend to the Mayor and Council a clause in the Ordinance that allows residents to remove invasive species from the 25ft non-disturbance zone.
